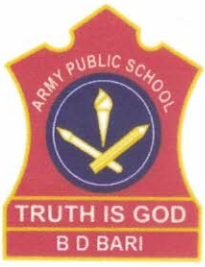

1.	Playing area of Synthetic Volleyball Court – 18 mtrs x 9 mtrs		
2.	Total area required (free zone) 28 mtrs x 15 mtrs		
3.	<b>Soil Treatment</b>		
	(a) Excavation of ground upto depth of 9 inches from the ground		
	(b) Removing all weeds and grass from its roots of the ground area		
	(c) Removing of excavated soil		
4.	<b>Civil Work</b>		
	(a) Excavation upto 9 inches, watering, compaction and dressing, excavated giving a gradient of 1:120 towards one side depending where the main drainage is located (Excavation levels determines so as to keep the finished levels minimum 6 inches above the surrounding areas)		
	(b) Application of weed killer and soil stabilizer		
	(c) Providing and laying 6 inches thick WBM, in one layer of 4.5" with hand broken at site, the same will be compacted, watered all the voids will be filled with kapchies and quarry soils and mohurum		
5.	<b>Asphalting</b>		
	(a) Providing and applying tack coat at 0.5kg per Sq mtr after thorough cleaning of surface and prior to laying of asphalt macadam, compacted thickness with bitumen.		
	(b) Laying of 40mm thick asphalt macadam with bitumen 80/100 grade with PPT with graded sieved aggregate funder to 25mm in bitumen.		
	(c) Laying of 25mm thick asphalt concrete manually/paver with bitumen grade 80/100 – 4% to 5% with graded aggregate with maximum size of ½" graded down to fines of 25% and allowed to cure for 24/30 days maximum the asphalt mix will be with PPT 1.2%		
	(d) Spreading manually grit powder mixed with PPT and cement on the finished asphalt surface to close the porosity of free asphalt and allowing the surface to surface to be dried for minimum 30 days prior to laying of the synthetic surfacing		
6.	<b>All Season Synthetic Surfacing (8 Layer) (18 mtrs x 9 mtrs)</b>		
	(a) Consists of 8 layer Acylic cushion system, one coat of bio cum primer/resurface, two coat layer of heavy cushion, three layers of fine cushion (Rubberized) two layers of colour (Red & Blue) line marking of court (White/Yellow colour)		
7.	<b>Support Wall</b>		
	(a) Dimension of wall (Height 1 ft x Width 9 inches)		
	(b) Brick work cement 1:4 (1 cement : 4 core sand)		
	(c) Providing and laying plaster 12mm cement mortar 1:4 (1 cement : 4 core sand)

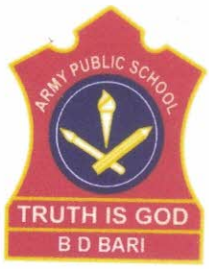
